Below are several frequently asked questions about the contract. For clarification, please coordinate with your local procurement officials and Fairfax County procurement. Additionally, RFP addendums 1-5 contain additional questions asked while the RFP was open, along with responses to those questions from Fairfax County.

Q1. Where does information exist about pricing?

A1. Preliminary pricing information for the rest of Virginia is located in the Notice of Award. Preliminary estimates for monthly recurring costs are available there for other Virginia PSAPS. "Optional" Special Construction costs are TBD. VITA staff is working to gain more information about these costs as they are available.

Q2. Where does information exist about cooperative procurement?

A2. There are several references to cooperative procurement in the RFP Addendums as responses to questions. These point back to the RFP document listed above, in Section 28 of the "Special Instructions" (page 14 of the PDF in the RFP link). This section is entitled "Use of Contract By Other Public Bodies"

Q3. How is billing expected to work for a transition project?

A3. Please see section 28 of the "Memorandum of Negotiations" (page 17 of the PDF in the link to the Acceptance Agreement). This section is entitled "Principal Billing Agent for a Transition Project"

Q4. Why are portions of the AT&T Technical Proposal redacted?

A4. Pages 15 and 16 of the PDF for the AT&T Technical Proposal provides information about a Request for Protection of Trade Secrets or Proprietary Information Pursuant to Article 2, Section 4.D.3 of the Purchasing Resolution and Va. Code Ann. § 2.2-4342(F). These pages identify the sections for which protection was requested.
