New College Institute provides the best of both traditional and innovative postsecondary education, continuing and professional development, community leadership, and deep-rooted partnerships to create a culture of creative thinking and problemsolving that is responsive to current and future needs. NCI does this by offering the following: A highly collaborative, technological environment and opportunities to participate from virtually anywhere with access to broadband and to technology. Our information technology at New College Institute fulfills these request by using state-of-the art technology to teach and educate our partnering colleges, universities, and our K-12 local schools. Technologies that are used to educate individuals are Polycom, Crestron, Extron, and Steelcase. Our infrastructure is supported by Cisco routers, switches, and firewalls along with VMware software to manage our servers for Active Directory, Fileshare, Domain Controller, Anti-Virus, and VEEAM Backup. The facility is monitored by our POE (power over Ethernet) security camera system. Classes and events are scheduled using a web-based software called Officetracker. NCI will also maintain is web-based hosting service through HD Web Studios located in Martinsville, VA.
