Current IT State

The Department of Wildlife Resources (DWR) relies on cost effective and efficient technology to enable the agency's vision to lead wildlife conservation and to inspire people to value the outdoors and their role in nature.

DWR is a non-general fund agency dependent on licensing and boat registration customers who contribute more than two-thirds of the department's annual revenue. Operational investments support employees in 6 regional and district offices statewide in addition to 9 hatcheries. DWR also has a significant mobile workforce, with over half of its 450 fulltime employees working remotely.

DWR is a regulatory agency in an increasing competitive outdoor recreational market. It is critical for the agency to understand its customer base and provide technology solutions that meet their needs. The agency has existing investments in online and point-of-sale licensing, registration, education and consumer sales (Go Outdoors Virginia, Kalkomey Event, Volunteer and Certification Manager, PSA Subscription Management), geospatial technologies (VA FWIS), law enforcement communication and workflow (Zuercher), financial management (Cardinal, eVA) and IT infrastructure.

Several online solutions will be eligible for renewal or re-competition of originating contracts during the next biennium. As regulatory services such as licensing and registration are the primary source of revenue, the agency will be focused on identifying and securing transformative and cost effective solutions. Existing IT investments for geospatial and law enforcement software have been recently contracted or renewed for the biennium. Funding for these, as well as funding for other hardware and software, are within the agency's budgeted scope.

Factors Impacting the Current IT

DWR is impacted by internal and external imperatives. Externally, the agency's major source of funding, license sales, reflects a shrinking number of recreational wildlife customers. In order to remain relevant, the agency must be more responsive to and invest in an increasingly tech savvy constituency. DWR's Go Outdoors Virginia and Kalkomy solutions are examples of this investment.

Internally, the agency is required to comply with Commonwealth mandates for financial systems, maintaining current software and hardware platforms including cloud hosting, and for growing requirements for information security. These new mandates must be met while maintaining current operational investments.

STABLE FUNDING and CUSTOMER RESPONSIVENESS: During this biennium, DWR's contract for its major customer facing funding source will be eligible for renewal. DWR will undertake an agency wide strategic analysis of business needs for a solution that will address current and future needs. Customers are increasingly tech-savvy and expect their government services to be available 24/7. The primary goals for new services will include improvements in customer recruitment and retention as well as no interruptions in revenue.

DIGITAL GOVERNMENT and BIG DATA: As with most agencies, DWR has more data than information. A key opportunity for the new biennium will be managing an increasingly complex data landscape.

INTERNET UTILIZATION: DWR personnel are increasingly mobile, which results in more internet utilization. DWR will continue its ongoing evaluation of bandwidth and overall connectivity at its regional, district and hatchery locations to ensure employees are afforded the most cost effective options as offered by the multi-supplier model.

CLOUD APPLICATION HOSTING: DWR will re-assess its strategies for data hosting in the next biennium. Applications under consideration are cloud-ready.

Proposed IT Solutions

The agency's critical solutions will maintain the agency's revenue flow and will increase operational efficiencies through lowered costs. The agency will evaluate proposed IT investments based on the applicability to strategic goals and return on investment. As DWR is a specially funded agency, technology solutions must be aligned within the agency's ability to fund them.

DWR will be evaluating IT business solutions for online customer licensing, registration, and customer relationship solutions during the biennium. There are several national vendors offering services specific to natural resource agencies. Their offerings will be evaluated on effectiveness, efficiencies, and cost.

DWR will transition to Cardinal HCM in October 2022. The agency may explore options to enhance Cardinal offerings; for example, internal budget management tools, grant management, and asset monitoring software. If Cardinal options are not suitable, the agency will review enterprise options.

DWR will continue to support its remote workforce with applications and technologies that enable virtual collaboration. The agency will monitor for network upgrades and will be updating firewall security as needed.

DWR will transition to Microsoft Messaging platform in August to October 2022 timeframe. The agency will be financially impacted by the increased costs related to this mandate as a non-general fund agency.
