VITA ePen is an electronic signature (e-signature) that will allow agencies to add branding and securely obtain signatures on electronic documents (e.g. .pdf and Microsoft products). VITA ePen can be used to record signatures from COV users, agency partners and citizens without quantity restrictions. It has a smooth and intuitive user interface. Some use cases for VITA ePen include artifacts such as contracts, invoices, proposals, memoranda of understanding and non-disclosure agreements. Parties signing a document do not require a license.



Digital documents and contracts can capture legal signatures from single or multiple people

Reduces time spent processing data on manually filled/scanned in documents and forms

Use eSignature web-interface to **track multiple documents for status and details** of use by recipient – no need to track via email



POWERFORMS

- A PowerForm is a template that allows you to create **self-service documents for signature without writing any code**. A PowerForm is initiated from a unique, secure URL that you make available for signers to complete.
- This is different from a template which you send to signers. Signers can access and sign your forms on demand, making PowerForms a way to capture signatures and data from people whom you do not know ahead of time.

WORKFLOW AUTOMATION (AGREEMENT ACTIONS)

By using Agreement Actions, you are able to archive documents to cloud storage providers (such as Google
Drive, Box, OneDrive or SharePoint) or export data from PowerForms to external applications (such as Google
Sheets).

 - API-based solution using DocuSign Connect handles around 1,700 submissions per month
- Virginia Department of Transportation Contractor COVID-19 tracker
 - Uses workflow automation for archiving completed forms are archived to VDOT's SharePoint site
- Small Business Supplier Diversity Small business investor grant (SBIG) form
 - Uses PowerForms to automate grant submissions simplifies a highly time-consuming process
