JAWS Inspect refresher

Join us on **Tuesday, April 9 at 10 a.m.** for a one-hour course on JAWS Inspect. This training is intended for current JAWS Inspect users who would like a refresher on using the software.

For anyone not familiar with the tool, JAWS Inspect runs a report of webpages to see how they would interact with the JAWS screen reader. It's a lightweight, easy-to-use tool available to agencies. If you're interested in learning more, reach out to the WebMod team. If there is enough demand, we will schedule a longer training session for new users.
