Executive Branch agencies, which are considered in-scope to VITA's services, should utilize this list to determine which commodity codes should be acquired through a VITA service (those coded with a "Y") and those which should be purchased (those coded with an "N") using a VITA statewide contract if applicable.

Other agencies and non-exempt institutions of Higher Education should use this list solely to identify which commodity groups are subject to VITA's Authority and Policies and Procuderes rather than those published by the Dept. of General Services.
